Brothers and Sisters,

The Southeastern Division of the International Association of Fire Chiefs has been active over the last several months. The executive board and state directors have continued to meet virtually monthly. We were able to hold our first board meeting face to face at our 93<sup>rd</sup> Annual Leadership Conference in Biloxi.

This year's conference we were joined with the Mississippi Fire Chiefs. The conference had over 200 registered attendees with the Mississippi Firefighters bringing another 300 to their conference. We had a good showing from our state. Our exhibitors came out in full force to support the conference in the post Covid setting. The educational program brought us tips from Disney, behavioral health, dealing with performance appraisals and the new era of electric vehicle hazards. The presidents of all of our member states, state directors, executive board and the executive director of the IAFC met to discuss current issues with the IAFC and issues across the fire service. The attendance was greater than expected for both the educational sessions and the exhibition hall. 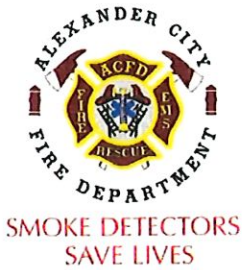
Meeting highlights are as follows:

Southeast Alabama Fire Chief's Association (SEAFCA) meets on a bi-monthly basis, during the first full week of the month. The meeting is held at various locations to discuss any old and new business, as well as, expenditures and budgets for the SEAFCA.

SEAFCA mailed a letter to Governor Kay Ivey on behalf of all departments within the region concerning reimbursements for CARES Act Funding issues.

Leadership changes were made at the beginning of the year. Chief Reese McAlister of Alexander City Fire Department was voted to serve as President of SEAFCA. Chief Cory Spurlin of Opp Fire Department was voted as Vice-President. Chief Matt Jordan of Auburn Fire Department was voted as Secretary/Treasurer.

Tim,

I am writing to report on the activity of the Alabama Fire College and Personnel Standards Commission since my update at the mid-winter conference in February.

We held our regularly scheduled quarterly meeting on April 21st. At this meeting, we approved some expenditures for priority items in the capital improvement plan that needed attention ahead of schedule. These included the refurbishment of Mobile Burn Trailer #3 and the purchase of a new over-the-road tractor for transporting mobile props. We also began consideration of an Administrative Code change for the Certified Rescue Technician certifications due to recent changes to NFPA 1006. This will include adding a third level of certification resulting in awareness, operations, and technician levels. Lastly, we received an update on the planned prop/storage building project and approved moving forward with the bid process for this major construction project with an estimated cost of \$3.2M.

Most recently, we met on July 21<sup>st</sup> for our regularly scheduled quarterly meeting. One of the main focuses of this meeting was consideration of the FY22 budget. With increased appropriations from the Legislature, we were able to approve a balanced budget which includes additional critical AFC staff and several improvements to campus and equipment. We gave final approval for the Administrative Code changes to Certified Rescue Technician which will now be titled Certified Technical Rescue Personnel with three levels of certification. We also approved a change to allow Fire Inspector II to be taught as a field delivery course. We approved entering into MOU's with in-state federal (DOD), quasi-government, and private sector firefighting agencies to allow their firefighters to maintain Alabama career firefighter certification while employed as a firefighter. We received updates on training facility requests from Opelika for consideration as an RTC and Tuscaloosa for ARFF training. The staff will be looking into these requests and will bring back a recommendation at a future meeting. Lastly, we acknowledged the resignation of Commissioner Ledbetter on May 17<sup>th</sup>, 2021. The AFA Commission seat will remain vacant until an appointment is made by AFA and confirmed by the Alabama Senate.

**Re: Summary Brief (Michael A. Bartlett, Association Representative to the Alabama State Emergency Medical Control Committee {SEMCC})**

Chief Love:

SEMCC has, after almost two years, scheduled a meeting for 2 November 2021. This will be held in conjunction with the Alabama Ambulance Association and the Alabama EMS Conference in Orange Beach, Alabama 31 October through 4 November. I foresee several topics of discussion in this upcoming meeting.

Two pieces of legislation have recently been ratified which affect EMS. First is the Community Paramedic License that has some big issues for Fire and EMS community. A prerequisite to obtain a Community Paramedic License is to have an EMS Paramedic license. Thus, each newly licensed Community Paramedic will take away an EMS Paramedic that we are suffering shortages with currently. Also, the Community Paramedic Program is not clearly defined and does not seem to accommodate the fire service as we operate utilizing jurisdictional boundaries. The current plan of the program appears to be hospital discharge based, not geographic.

Second, Paramedics somehow got included in a DUI Act that was ratified this session. This includes Paramedics as professionals that can make DUI blood draws. Although the legislation stops short of mandates to do so under order of a law enforcement official, it does open the door for the paramedic community to be served bench warrants to mandate this action, especially in areas of the state where hospitals are not readily available.

I expect this, plus more issues facing EMS Providers, to be addressed at this year's SEMCC Meeting.

#### **Bills Supported and Passed:**

HB77/SB156 – ACT#2021-432 Tag fee for memorial and for Peer Support

HB81 – ACT#2021-270 Hazardous duty time calculated into fire, police, etc. for making 25 years when death or debilitating injury occurs prior thereto.

HB94 – ACT#2021-XXX Forestry added to LODD benefit and 24 hour rule put in place for volunteers (mirror federal statute).

HB112/SB38 – ACT#2021-366 Alabama Fire College Executive Director is able to issue Peer Support Certification that provides legal protection for providers.

HB153 – ACT#2021-425 Bill would allow a dependent natural child under the age of 21 born after death (or adopted child adopted less than 21 before disability) to be eligible for scholarship. (Public Safety)

HB386/SB55 – ACT#2021-399 Establishes new fees for fire marshal's office. Five percent of fees go to Annuity and Benefit Fund Commission.

HB297/SB189 – ACT#2021-342 ETF Budget with Fire College Increase

HB309 – ACT#2021-XXX General Fund Budget with Forestry portion intact.

HB118/SB114 – ACT#2021-429 Rescue Squad trailer tag bill (supported)

HB423 – ACT#2021-294 Allow for public contracts to be issued for push to talk service to any vendor.

HB532 – ACT#2021-XXX. Expands coverage of presumptive legislation into 10 years of retirement for paid fire service.

HB446 – ACT#2021-336 Secured protection of local and municipal governments to inspect utility connections for code violations and safety.

HB510 – ACT#2021-245 Birmingham Retirement and Relief System contribution rates changed to benefit fire service.

**Bills that were passed with our opposition:**

HB141/SB115 – ACT#2021-303 Community Paramedicine Program. Implications and rules are not known as this time.

HB220/SB194 – ACT#2021-XXX Executive Amendment delayed implementation of the provisions of this act for a period of time and established a study to look at the implications of this legislation. AAFC has a seat at the table.

**Bills Successfully Opposed:**

SB324 – Removing requirement for physical fitness for class 1 municipal department paramedics.

SB256 – Red Light Bill. Five amendments proposed halted any movement at the committee level in the House.

There are still some things on the table for next year and we have time to get them ready. All in all it was a successful year thanks to the efforts of the entire group.

Re: Report to AAFC E-Board from CABT representative

Tim,

I am writing to report on activity of the CABT – Coalition Against Bigger Trucks since our mid-winter conference in February. This coalition was formed to resist any efforts of Congress that would allow for larger, longer, or heavier trucks on our roadways, and the AAFC has stood firm as a supporting member. The coalition group in Alabama consists of representatives from public safety (AAFC, AAVFD, State Troopers Assoc., Sheriffs Assoc.) and ALDOT. In late February, I had an opportunity to join Rick Cowan from CABT on a Zoom call with Senator Tuberville's senior staff in order to better inform them of our position on bigger trucks. The meeting went very well, and I feel that our points were well received. In March, we were informed that an infrastructure bill had been filed by Rep. Gallaher in WI to allow for heavier logging trucks on interstates. We joined the CABT in sending letters to our congressional members opposing any such action. In May, we learned that several big lobbying groups were pushing for bigger, longer trucks as part of the infrastructure package. Specifically, FedEx was lobbying for double 33 foot trucks, claiming it would help the environment. The forestry industry was pushing for an increase to allow massive log trucks, up to 156,000 pounds, on interstates in up to 30 states. Another lobbyist was pressing for a pilot program that would allow an increase of up to 91,000 pounds with 6 axles on interstates. Fortunately, we received information in late May that the Surface Transportation Reauthorization Act of 2021 had no national truck size or weight increase included in the bill. The House followed up with its own infrastructure bill, also free of any national truck size or weight increases. Lastly, on June 16<sup>th</sup>, a key Senate panel denied efforts of bigger truck proponents to include language allowing larger and more dangerous trucks, and approved a transportation reauthorization bill without any such provisions.

We will continue to monitor activity in Washington, and I will continue to work with this group to represent our public safety interests. Please forward any questions or concerns that you or the AAFC members might have regarding this issue.

### **Turn Your Attention to Fire Prevention - Summer 2021 Report**

Chief Love,

Thank you for the opportunity to serve on the Turn Your Attention to Fire Prevention Committee for the AAFC. This past year, I was able to attend our mid-winter conference in Hoover in February and the SEAFCA Conference in Biloxi in June. I have also been able to attend a few CAFCA and NAFCA meetings. I am not going to be able to attend our summer conference this year due to being at the National Fire Academy for Leadership Strategies for Community Risk Reduction. I am hoping to be able to bring a lot of information back from this course to help revitalize our TYATFP campaign.

Please remind our membership about the Twin States Safety Summit on August 20, 2021, at the Meridian Community College Riley Workforce Center from 9am-3pm. This is a joint training event between the Alabama Coalition of Community Risk Reduction Educators and Mississippi Association of Public Fire Safety Educators. The ACCRRE, the Alabama Fire College, and the Mississippi Fire College have all been working hard the past few months making preparations for a live, in person safety summit that will be packed with great information to help our departments develop and deliver CRR programs that will have bigger impacts in our communities.

The fire college also continues to offer Fire and Life Safety Educator I & II courses at least 6 times per year for each level. I have started the discussion with the fire college for these courses to be added to the field course delivery list, so they can be taught at the department level without fees. Work continues on the fire safety trailer donated by Vestavia Hills FD. Covid and a few other issues have slowed progress, but hopefully this asset will be available for use soon.

While at the conference in Biloxi, I met with Chief Martin and several others to try to develop ideas to improve our educational presence not only in each of our communities, but getting back to a statewide TYATFP presence. The constant in each of these conversations kept coming back to 2 things. 1<sup>st</sup> and foremost, we as the Chief of the Department HAVE to give fire prevention & education a priority and show our departments it is important enough for everybody in the department to be involved in, starting with and including US, the chief of the department! The commitment we set, as chiefs, towards fire prevention education ultimately sets the stage for whether or not we will have a successful fire prevention program in each of our communities, and the success of the statewide TYATFP campaign relies on the commitment and constant involvement from each AND every one of our departments.

The second thing that came up in numerous conversations was we need more involvement from more departments. We still have trucks that do not even have the TYATFP logo. We still have departments that are not pushing smoke alarms and more importantly, some that do not even know about the smoke alarm program or how to get smoke alarms for their communities.

The latest smoke alarm numbers showed less than 1000 install reports returned for almost 3000 alarms that were delivered this year. There are a couple departments currently conducting install blitz campaigns, so these numbers should increase considerably when they are installed.

Although the fire fatality numbers are also not completely up to date, as of early July, we have already past 50 fatalities for 2021. Most reports are still listing smoke alarms as unknown, which leads to deficiencies being encountered in either reporting or working smoke alarms being present and alerting the occupants. Since the lack of functioning smoke alarms continue to contribute significantly to our fatality numbers, we cannot emphasize enough the need to continue to make smoke alarm installation and education one of our prevention priorities.
