

**Re: AAFC Commissioner Report from AFC** 

#### **President Green and AAFC Members:**

This report provides details of activity with the Alabama Fire College and Personnel Standards Commission.

We held the most recent quarterly meeting on April 27th. At this meeting, Commissioner Brandy Williams (AAFC) and Commissioner Allan Rice (AFA) took an oath of office and had their first official meeting. We held a groundbreaking ceremony for the new Prop Storage Building, estimated completion date on this is January 2023. We discussed making changes to the administrative code to increase Certified Firefighter Recruit School hours from 360 to 400 and to increase the hours for the Bridge Program from 200 to 240. After a lengthy discussion, we voted to table the discussion until the July meeting so we could take a comprehensive look at the impacts of this change.

We received an update from Tracy McNair on the next phases of the new Learning Management System and Department Dashboard. Commissioner Mike Green's (AAVFD) last commission meeting was in April, we presented him with an award for his dedication and service to the commission for the past 8 years. He will be replaced in July with Josh Bryant. We voted and passed to add Peer Support Member to the administrative code. This will allow it to be recognized as a course and a certification can be issued. We voted on and passed Public Fire and Life Safety Educator 1 to be released as a field delivery course. The City of Birmingham requested assistance from the AFC to assist with procuring AEMT's and Paramedics to support and supplement their limited EMS staff for the World Games to be held in the Birmingham area July 7-17, 2022.


We voted to approve Semmes Fire Department to become an RTC. We voted and approved a language change to the Physical Statement that must be submitted to AFC prior to beginning certification for certified firefighters and volunteer firefighters. This form must be submitted within 30 days of employment for those not currently certified. Since the start of 2022, the EMT self-study class has enrolled 18 students.

At the January meeting, a new contract for lodging was approved and awarded to Comfort Inn & Suites. A repaying project for the campus was also approved and has now been completed. The CoAEMSP site visit report was given with no issues and very positive feedback for the EMS training team. At the April meeting, we were informed that we received official notification from CAAHEP that we have been awarded continuing accreditation status as a result, next site visit isn't until 2027. The AEMT and Paramedic courses continue to grow.

## Re: Summary Brief (Michael A. Bartlett, Association Representative to the Alabama State Emergency Medical Control Committee {SEMCC})

#### Chief Green:

From my last report on 25 January where I reported I had been asked to advise and follow several pieces of legislation from the Joint Fire Council and Alabama Ambulance Association. Specifically, HB3 - EMA definition change, HB72 - Lottery bill, HB126 - Certificate of Necessity for air ambulance, SJR7 - Trauma funding committee, LSA-KF - ARPA fund disbursements and LSA2022-237 - the EMS Bill. These were followed, influenced and resolved as follows:

- HB3 after evaluation was not an issue effecting EMS in the state.
- HB72 did not see the light of day. .
- HB126 Died with no support. .
- SJR7 This activated the state trauma funding committee with some 14 Million available to spend. The two EMS seats were self filled by two members of ADPH/OEMS. In working with AAAS, HJR34 was created which added two seats for EMS providers (1-Private/ 1-Public). HJR34 passed and was ratified. I now serve as the public sector EMS provider representative as appointed by AAAS. Letter enclosed.
- LSA2022-237, The EMS Bill turned into HB190/SB183 and was subsequently passed and ratified making EMS an essential service as recognized by Alabama State Law.
- ARPA fund disbursements. This was approved and 10 Million was allocated for EMS/AARS/9-1-1 centers. EMS services that qualified were allowed to apply for \$10,300.00 per service.
- HB287 was a new bill that came up known as, The Medicaid Assessment Program. This bill passed and details are being worked out. The basic synopsis of the bill calls for an assessment paid by transport providers on a quarterly basis to Medicaid for every transport made. In return, Medicaid pots the money with CMS at a 3:1 return. The Alabama pot returns to Alabama matched at a 3 to 1 ratio. At this point Medicaid ambulance claims will be paid at a commercial rate.

As suggested in the Mid-Winter Brief, Act 2021-48 (AKA DUI Bill) created issues as it authorized Paramedics to perform DUI Blood Draws. At the SEMCC meeting of **2** November 2021, I did address this by moving that SEMCC amend the scope of practice in the 10<sup>th</sup> Edition of the State protocols to prohibit the performance of *non-medical* blood draws in the field. The motion was seconded and carried. <u>This excerpt from the SEMCC minutes is enclosed</u>.

In April 2022 the amended rules and 10<sup>th</sup> Edition of the State protocols did go into effect. Also, please be advised that in 2023 ALS provider services will be required to carry a narcotic, either Morphine or Fentanyl or both. Also, provider services re-licensures in 2023 will require a quality improvement plan to be submitted.

Finally, on 2 May 2022 ADPH/OEMS released a memorandum stating they have transitioned to NEMSIS 3.5. Most third party vendors and the State's no fee RESCUE software comply with NEMSIS 3.5. What is new in the Memo is the inclusion of the 3.5 data set in full. By adopting the data set guidelines, agencies would have to complete an epcr for every call they were dispatched on regardless of the call type. Fire alarm, cancelled en route, anything.

Contact was made with ADPH/OEMS to remind them in the current rules passed by SEMCC we are only required to complete an epcr when patient care is provided (EMS Rules 2022: 420-2-1.21(1)) excerpt enclosed. ADPH/OEMS has acknowledged this and stated they are willing to talk about some work-a-rounds.

## Minutes of the State Emergency Medical Control Committee (SEMCC) Meeting November 2, 2021 Orange Beach, Alabama

## Welcome/Call to Order

The meeting was called to order by Dr. Crawford. He thanked everyone for attending.

### Introduction of New Member

Dr. Crawford introduced Steven Tidwell as the new representative for the Ambulance Association of Ambulance Services. He stated that Mr. Tidwell replaced Jason Trammell, whose term had expired.

#### **Review of Minutes**

A motion was made and seconded to accept the Minutes of the November 5, 2019, Meeting; as distributed. The motion carried unanimously.

## **Old Business**

Death in the Field Protocol: Dr. Bowden proposed that the protocol needed to be updated due to much confusion. Dr. Crawford responded that the protocol presented by Dr. Bowden would be added to the *Operational Guidelines*, with a change that online medical control would not need to be contacted for obvious death in the field A motion was made and seconded to accept the proposed Death in the Field Protocol, and add it to the Operational Guidelines. The motion carried unanimously.

## **ALEA DUI Legislation**

Chief Bartlett expressed concern for potential problems regarding Act 2021-48, Senate Bill 258 - Alabama Law Enforcement DUI Bill, which allows paramedics to perform blood draws for law enforcement personnel. Chief Bartlett made a motion to amend the scope of practice in the 10<sup>th</sup> Edition of the Alabama EMS Patient Care Protocols to prohibit the performance of non-medical blood draws in the field. The motion was seconded and carried unanimously. care to a patient shall yield patient care responsibilities to a licensed physician when directed to do so by the on-line medical director.

(b) EMSP personnel shall yield patient care responsibilities to licensed EMSP when directed to do so by licensed EMSP of a higher level.

(c) EMSP shall discontinue patient care measures when directed to do so by the on-line medical director.

(5) On-scene disputes regarding patient care responsibilities shall be referred to the on-line medical director.

#### 420-2-1-.21 Patient Care Reporting.

(1) The EMSP providing patient care is responsible for the completion and submission of an electronic Patient Care Report (e-PCR) to the emergency medical provider service within 24 hours.

(2) Each emergency medical provider service shall ensure that an accurate and complete e-PCR is completed and submitted to the OEMS within the required time frames, and use software approved by the OEMS' Director.

(3) Each provider service shall provide a copy of the patient care report to the receiving facility as soon as reasonably possible. In no instance should the delivery of the report exceed 24 hours.

(4) Records and data collected or otherwise captured by the Board, its agents, or designees shall be deemed to be confidential medical records and shall be released only in the following circumstances:

(a) Upon a patient's presentation of a duly signed release.




Here are a few things for the report:


Re: Report to AAFC E-Board from CABT representative

#### Marvin,

I am writing to report on activity of the CABT - Coalition Against Bigger Trucks since our mid-winter conference in February. This coalition was formed to resist any efforts of Congress that would allow for larger, longer, or heavier trucks on our roadways, and the AAFC has stood firm as a supporting member. The coalition group in Alabama consists of representatives from public safety (AAFC, AAVFD, State Troopers Assoc., Sheriffs Assoc.) and ALDOT. In February, we received information that the Alabama Legislature was considering two bills (SB 157 and HB 368) that would increase weight limits on logging trucks in the state, among other things. We issued letters of opposition, and thankfully, both of these bills died at the end of the legislative session with no action taken. In March, proponents of larger and heavier trucks argued that the truck driver shortage throughout the country was justification to allow increases to size and weight. The CABT argued that finding qualified drivers for these types of trucks would only compound that problem in addition to all of the other reasons offered against such trucks. Lastly, I reached out to CABT for some information that our delegation of AL Chiefs at CFSI could use for continuing to state our case against larger and heavier trucks. CABT shared "With the passage of the 5 year infrastructure bill without any increases in weight or length, we still face the likelihood of proponents trying to get an amendment of some sort pushed through in the Appropriations process in May. So the ask continues to be to urge Congress not to allow any increases in commercial truck weight or length. We are seeing them use the driver shortage more and more as a supply chain argument for these increases." We are still waiting to hear if any actions have been proposed through Appropriations. Already in 2022, several other states have seen legislation introduced to increase truck sizes and weights within their state.



## Turn Your Attention to Fire Prevention - Winter 2022 Report

Chief Green,

Thank you for the opportunity to serve on the Turn Your Attention to Fire Prevention Committee for the AAFC. This past year, I was able to attend our midwinter conference in Hoover in February and the SEAFC Conference in Biloxi in June. I have also been able to attend several CAFCA meetings and a few NAFCA meetings and was able to attend several virtual meetings including the Twin States Safety Summit in August and numerous Monthly Fire Service Updates from the AFC.

Director Russell continues to work on the details needed to move the Fire & Life Safety Educator I course from a RTC / Campus delivery course to a department delivery course. Work continues on the fire safety trailer donated by Vestavia Hills FD. A few minor issues, the development of SOP's and logistical responsibilities have slowed progress, but hopefully this asset will be available for use soon.

We have been able to push out a lot of the TYATFP banners that were made last year and many have been used several times. We have built a new shoe board display that is available for TYATFP events.

So far this year our reported fatality numbers are at 10. This is pretty close to last year's numbers for January. As of the time this report was completed, our reported fatalities numbers for 2021 was at 97. <sup>1</sup>/<sub>4</sub> of the fatality fires listed included multiple fatalities. In 70% of the reported fatalities, the presence of working smoke alarms were either not reported or not present. Chief Coleman has built a Google Document to assist with keeping track with fatality information, but timely reporting of accurate information still seems to be a huge obstacle. The state fire marshal's office has pushed out a reminder that ALL fire reports need to be submitted ASAP.

There were 1832 smoke alarm installs reported in 2021. Mobile Fire installed 1198 of them. The AFC has created an online fillable report in both English and Spanish that can submitted at the time of the install from any mobile device. This form can be found on the AFC website under the Get Alarmed Alahama page or just by searching "smoke alarm" from the search bar on the home page. Smoke alarms continue to play a huge part in saving lives effected by residential fires and the continued success of this program and the continued availability of this program relies on each of our departments to continue to get out in our communities and install smoke alarms and make sure we are reporting the completed installs back to the AFC in a timely manner.

A project for this year is to possibly create an incentive campaign to help encourage departments to get out and install smoke alarms in their communities. Although this is open for discussion, if we can reach 3500 reported installs for 2022, we draw for 1 department to send 1 member to FDIC. For each alarm install reported the department will receive 1 chance in the drawing. The winning department will be drawn at the mid-winter conference. We can also recognize the department with the most installs with an award. Maybe split into career, combination, and volunteer. I think we can get sponsors for this project, therefore the expense to the association will be minimal.

Lastly, we need a few more members to get involved with the TYATFP committee if you have anyone interested.
